

ORDINANCE NO. 38

AN ORDINANCE TO AMEND CHAPTER 2, ARTICLE 1, SECTION 2-101(1)(a) OF THE CODE OF ORDINANCES FOR THE TOWN OF MARDELA SPRINGS, MARYLAND. THE AMENDMENT SHALL CHANGE THE DAY OF THE REGULAR PUBLIC MEETING OF THE COMMISSIONERS OF MARDELA SPRINGS FROM THE THIRD MONDAY OF EACH MONTH TO THE THIRD TUESDAY OF EACH MONTH.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Commissioners of Mardela Springs:

SECTION ONE: Chapter 2, Article 1, Section 2-101(1)(a) of the Code of Ordinances for the Town of Mardela Springs is hereby amended by deleting it from the Code and by substituting the following language in lieu thereof:

Section 2-101(1)(a). Time. The Commissioners shall hold one public meeting on the third (3rd) Tuesday of each month at 7:00 p.m. at which they will normally conduct the business of the Town such as transacting public business, enacting ordinances or resolutions, receiving citizen complaints and other communications. If the date fixed for any meeting falls upon a day designated by law as a legal or national holiday, such meeting may be held on some other acceptable day as a majority of the board may designate.

SECTION TWO: The balance of Chapter 2, Article 1, Section 2-101 of the Code and Ordinances for the Town of Mardela Springs shall remain in effect subject only to the changes set forth hereinabove.

SECTION THREE: This Ordinance shall take effect from and after the date of passage.

The above Ordinance was introduced at a meeting of the Commissioners of Mardela Springs held on the 21<sup>st</sup> day of April, 1997; and having been published as required by law and a public hearing having been held thereon, was finally passed at the meeting of the Commissioners of Mardela Springs on the 19<sup>th</sup> day of May, 1997.
